The Leduc Recreation Centre Corporate Membership program offers a 20% discount to your organization.

To participate in the Leduc Recreation Centre Corporate Program the organization must also commit to reimbursing their employees a minimum of 20% of the cost of the annual membership fee.

Employees of qualifying organizations can purchase their membership at any time throughout the year. This will enable new employees to participate in the Health & Wellness Programs immediately.

These memberships are non-transferable, non-refundable and cannot be combined with any other offers or memberships plans. The plan applies to annual memberships only.

When the employee wishes to register for the program, or when it's time to renew their pass, they simply identify themselves with proof of employment which can be a current pay stub or company ID card, (business cards will not be accepted as proof).

How Does the Corporate Discount Program Work?

Registration Is Easy!

- Complete and sign our Corporate Agreement form and assign a contact person from your organization to represent your organization and then complete and return our agreement form.
- Once registered each of your employees will receive a 20% discount off an annual membership at the Leduc Recreation Centre.
- When your employees come to the LRC to purchase their membership they will pay for their pass, less the corporate 20% discount.
- The employee will then submit their membership receipt to your organization for a minimum 20% reimbursement.
- Corporate memberships do not qualify for the EFT payment plan.
